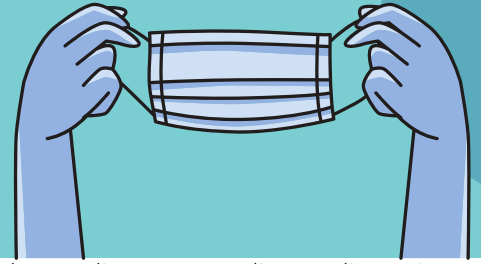


# COVID-19

## PREPARED



It is everyone's responsibility to **Reschedule if anyone is feeling ill**. This also applies to our stylists. A disruption to our schedule may occur if we are exposed to any illness. We are taking this seriously - even for the common cold or allergies. Our stylists will be tested every 2 weeks to ensure we have the information we need to help contain any possible breakout of COVID-19. In the event that someone tests positive, we will be contacting our public health department to provide them with the proper means to trace accordingly. Anyone coming into to our facility must accept the risks & understand that we are doing our best to keep everyone as healthy as possible. Our stylists are committed to following CDC Guidelines regarding COVID-19 as well as our County & California Orders. We expect the same of you. Our stylists have the proper sick leave to encourage them to stay home when ill.

We are limiting the amount of people in our salon at one time. Based on CDC & OSHA requirements we are keeping our styling stations 6 feet apart & staggering appointments to help maintain physical distance as well as providing physical barriers where necessary. We follow all guidance from Santa Clara County in regards to how many people can be within our space at one time.

All consultations will be done virtually via Zoom, Instagram or Facebook Messenger to allow our face to face conversations to be held in a safe manner. We are offering Video Coaching sessions & Video styling guides to help you learn our techniques from home while keeping us all safer from COVID-19.

Everyone will be required to wear a face covering while in our establishment. If you do not have a disposable face covering of the ear loop variety, one will be provided for you.

Our Stylists will have a face covering that they change between each guest & will be wearing a face shield &/or eye protection that is sanitized & disinfected between each guest.

Our Stylists will be wearing uniforms & our shoes will not leave our salon to avoid cross contamination. If you request we can provide you with shoe coverings as well.

Our salon has touch-less faucets & soap dispensers as well as hand sanitizer for us to use as frequently as needed.

Our salon has 24-7 Air Purification provided by Molekule that is shown to reduce the amount of contaminants in the air. We have UV-disinfection to maintain our shears & metal items. All drapes & towels are washed appropriately.

We utilize only the best in Sanitation & Disinfection solution that is registered by the FDA to be effective against coronaviruses, HIV, HEP-C & others. Feel free to research Barbicide. Our establishment will properly sanitize between appointments & shifts. We have all trained & hold certifications in COVID-19 & the use of Barbicide.

To keep cross contamination to a minimum we will be working in teams that do not mingle. All of our meetings will be held virtually via video. Our salon is sanitized between shifts as well as between appointments. Each team is treated as 1 & may be quarantined as a whole in the event of illness. Our pricing reflects the need to be able to quarantine at any time. Please understand that your service prices are based on skill, time, & product & will fluctuate accordingly.
